I, the undersigned Seller, do sell the aforementioned dog to the buyer for the amount shown and certify that the aforementioned dog is in good health according to licensed veterinary exam on _____.

I, the undersigned Seller, pledge to have given all the attention, care and precaution needed by the aforementioned dog while it was under my responsibility.

I, the undersigned Seller, do sell the aforementioned dog to the Buyer and certify that the dog is a purebred Golden Retriever. Both the dam and sire are registered with the American Kennel Club and the Canadian Kennel Club.

I, the undersigned Seller, acknowledge that the aforementioned dog is microchipped for identification. Microchip registration will be completed by Seller with the Buyer listed as the owner, and the Seller listed as the emergency contact. The Seller is to remain the emergency contact for the lifetime of the aforementioned dog.

I, the undersigned Seller, do sell the aforementioned dog to Buyer strictly as a pet on a non-breeding agreement. The aforementioned dog will not be used for breeding purposes by the Buyer or any other person.

I, the undersigned Seller, state that all of the information provided in the Purchase Agreement is true and accurate.

BUYER

I, the undersigned Buyer, acknowledge receipt of this Purchase Agreement and understand there is no guarantee or warranty, expressed or implied, with respect to the aforementioned dog beyond what is stated in this Purchase Agreement.

I, the undersigned Buyer, acknowledge and understand that the aforementioned dog is being sold to me on a non-breeding agreement. The aforementioned dog will not be used for breeding purposes by me or any other person. The aforementioned dog must be spayed/neutered on or before 24 months of age. I understand that I am to provide the Seller with proof of the sterilization upon completion.

I, the undersigned Buyer, acknowledge that in the event I am unable to or wish not to keep or care for the aforementioned dog for any reason, I must contact the seller to advise them of the situation, then the dog must be

surrendered back to Seller for rehoming. I acknowledge and understand that I am not allowed to rehome this dog to anyone other than Seller.

I, the undersigned Buyer, agree that Seller will register the aforementioned dog's microchip information. I agree that Seller will remain as the emergency contact on file with the microchip implanted in this dog for the duration of the dog's life.

I, the undersigned Buyer, agree to remain in contact with the Seller to provide updates of the aforementioned dog a minimum of once a year (e.g., on the dog's birthday). Any communication or media (text, images, photos, etc.) presented by Buyer to Seller - regardless of type - includes Buyer's permission for Seller to use as they wish.

I, the undersigned Buyer, agree to report any health or behavioral issues to the Seller immediately. I also agree to immediately notify Seller should death of the aforementioned dog occur along with the cause of death.

I, the undersigned Buyer, agree to notify the Seller of any and all changes in my contact information (phone number, address, email address, etc.).

I, the undersigned Buyer, acknowledge and understand that the Seller is not responsible for any accidents, injuries, or illnesses not covered by health guarantee to the aforementioned dog, immediately upon signing this agreement.
